CRITERIA

1. **Local** - the funds must be used locally, and
2. **Charitable** - must be an organization, not an individual, that is clearly philanthropic in nature, and
3. **Special Function/Program** - the Rotary Club must see a specific end result or program/project (no general operations, salaries, administrative and maintenance costs).
4. **Broad Based Impact** - the contribution must reach a large segment of the Gilroy community, and
5. **High Visibility for Gilroy Rotary** - if possible and appropriate, the applicant that receives a contribution must agree to publicize the Gilroy Rotary name or symbol as part of the program, activity, etc.
6. **No money will be given to any charitable organization for scholarships.**
